#### I. ARTICLES OF INCORPORATION

# ARTICLE IV POWERS AND DUTIES

- **Section 2. Specific Powers.** The Association's Board of Directors shall also have all of the powers and authority reasonably necessary or appropriate to carry out the duties imposed upon it by the Declaration, including, but not limited to, the following:
- (f) To make and amend reasonable Rules and Regulation respecting the Condominium Property use of any property or facilities over which the Association may have control, jurisdiction or administrative responsibilities, and to provide the penalties for the violation of any such Rules and Regulations; provided, however, that all such Rules and Regulations and amendment thereto may be rescinded (except for the initial Rules and Regulations which may be adopted by the first Board of Administration) shall be approved by not less than sixty percent (60%) of the votes of the entire membership of the Association before same shall become effective;

#### II. BYLAWS

# ARTICLE IX RULES AND REGULATIONS

The Board of <u>Directors</u> <u>Administration</u> may adopt reasonable <u>R</u>ules and <u>R</u>egulations to be uniformly applied to all members of the Condominium governing the <u>Condominium Property</u> <u>details of the operation and use of the Common Elements</u>. <u>The membership may rescind such R</u>ules and <u>R</u>egulations <u>may be amended or rescinded enly</u> at any regular or special meeting of the members by vote of at least sixty percent (60%) of the entire membership <u>of the Association</u>.
